DAMALERIO AND MUNICIPAL TREASURER MELONEY C. DUMADAG FOR THE LEGISLATIVE BRANCH OF LGU-CALAPE AS THE OFFICIAL SIGNATORIES OF ALL ACCOUNTS OF THE MUNICIPALITY CALAPE, BOHOL AT THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), TUBIGON BRANCH, LAND BANK OF THE PHILIPPINES (LBP), TUBIGON BRANCH AND PHILIPPINE VETERANS BANK (PVB), TAGBILARAN BRANCH, EFFECTIVE JULY 01, 2025 UNTIL JUNE 30, 2028.**

**"RESOLVED FURTHER**, that SB Member BILL MARK R. YU is hereby authorized as Alternate Signatory of Mayor SULPICIO N. YU, Jr.;


**"RESOLVED FURTHER**, that the authority under this resolution will continue to be effective and applicable during the said period of time unless amended for justifiable and necessary reason/s;

**"UNANIMOUSLY ADOPTED.**


