RESOLUTION NO. 2025-180

A RESOLUTION CREATING THE STANDING COMMITTEES OF THE SANGGUNIANG BAYAN OF CALAPE, BOHOL FOR JULY 09, 2025 TO JUNE 30, 2028.

"WHEREAS, Section 50 of the Local Government Code of 1991 states that on the first regular session following the election of its members and within the ninety (90) days thereafter, the sanggunian concerned shall adopt or update its existing rules of procedure which shall provide for the creation of standing committees, among others;

"WHEREAS, the standing committees are hereby created and their compositions are hereby established as agreed upon by the Sangguniang Bayan Members;

"WHEREAS, the committees are vested with authority to make investigations and ascertain or collect facts on matters being referred and make report with recommendation thereon for fuller information of the Body;

"NOW, THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Bayan of Calape, to create its standing committees with jurisdiction and composition of each committee, as follows:

1. **Committee on Rules.** All matters related to revision and enforcement of Sanggunian rules, organization of committees, codification of ordinances, legal aid; and the conduct, rights, privileges, dignity, integrity, and reputation of SB Members;
