**RESOLUTION NO. 2025-181**

**A RESOLUTION CREATING A BARANGAY CLUSTERING IN THE MUNICIPALITY OF CALAPE, BOHOL WITH THE AGREED ASSIGNMENT OF EACH SANGGUNIANG BAYAN MEMBER TO ANY CLUSTER FOR JULY 09, 2025 TO JUNE 30, 2028.**

"WHEREAS, the Sangguniang Bayan Members of this municipality are elected to serve the town of Calape and its entire population to their best of talent and ability;

"WHEREAS, for proper governance and coordination with barangay officials and its constituents, it is of paramount importance that groupings of barangay shall be created wherein all Sangguniang Bayan Members shall be assigned as their area of concern;

"WHEREAS, considering that SB Members are elected to serve the whole municipality, it is the prerogative of any SB Member to attend any activity of the barangays which is not her/his area of concern; provided on "the best effort basis" there is a coordination or prior information with concerned Sangguniang Bayan Member and provided further that it should be done without creating any malice or intent to damage the reputation of any Sangguniang Bayan Member;

"WHEREAS, that such kind of intention shall be effective in helping the barangays, the welfare of its population and a tool for effective management as a whole;

"NOW, THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Bayan of Calape, to create a Barangay Clustering in the Municipality of Calape, Bohol with the agreed assignment of each Sangguniang Bayan Member to any cluster from July 09, 2025 to June 30, 2028 as follows:

- District No. 1 - MANTATAO, SAN ISIDRO, MAGTONGTONG and MADANGOG

- District No. 2 - SOHOTON, CATMONAN, LOMBOY and BONBON

*For Hon. KEVIN REYS M. DAMALERIO*
- District No. 4 - CABUDBURAN, CAMIAS, BENTIG and SAMPOANGON  
*For Hon. BILL MARK R. YU*
- District No. 5 - DESAMPARADOS, LIBORON, TINIBGAN and TULTUGAN  
*For MA. LEONORA G. RULONA*
- District No. 6 - ABUCAYAN NORTE, BINOGAWAN, ULBUJAN and CANGUHA  
*For Hon. JOSE A. JUMANGIT, Jr.*
- District No. 7 - TALISAY, KAHAYAG, LOOC, BANLASAN and LAWIS
